Rules and Regulations

It is mandatory for each trainee to abide by the following rules during the entire period of being registered as a trainee in any course at this institute:

- 1. The individual will have to pay the full amount of the fees along with the registration fees at the time of admission. However on request the same may be paid in two equal instalments as decided by the Institute.
- 2. On withdrawal from the institute within 3 days of admission, the course fee (amount paid by the individual at the time of admission) will be refunded. The registration fee is non-refundable.
- 3. The trainees will have to attend a minimum of 80% of the classes conducted for the chosen course in order to be eligible for the Diploma/Certificate in the said course.
- 4. A trainee will be held liable to the institute for any damage of property of any kind and in any manner, caused by him/her, during the period of the chosen course.
- 5. On successful completion of the course a trainee will have to appear for a qualifying examination. Only on passing the qualifying exam by securing a minimum of 40% marks, will the trainee be awarded with a completion certificate.
- 6. However the Institute reserves the right to modify/change the above mentioned rules and regulations at any time it deems fit for the betterment of the Institute and the trainees.
